Vice-Chair Byrain Boes called the meeting to order and all present recited the Pledge of Allegiance.

Approval of Agenda: Motion by Lance Matucha, second by Doug Janousek to approve the agenda as presented to the Board. All members present voted aye. Motion carried.

Vision/Dental/Life Insurance Policy: Motion by Lance Matucha, second by Doug Janousek to switch the County's vision-dental-life insurance policies from Reliance Standard to Colonial Life effective at the renewal date. Colonial Life has much better coverage at better premium rates. All members present voted aye. Motion carried.

Employee Salary Increase: Motion by Doug Janousek, second by Lance Matucha to grant a \$.20 per hour increase to Zachary Albers as he has completed his 6-month introductory period, effective October 11, 2023. All members present voted aye. Motion carried.

Temporary Help: Motion by Jeff Johnson, second by Doug Janousek to hire Jay Broome as temporary help beginning October 16, 2023 at \$15.00 per hour. Mr. Broome will work approximately 3 hours per day, Monday-Wednesday-Friday, until Wendy Broome, Custodian can return to full-time work capacity. All members present voted aye. Motion carried.

Groups or individuals who desire to utilize the Gregory County Courthouse parking lot for private or public events, must apply to the Gregory County Commission for approval. Upon approval, the group or individual must sign a document which holds Gregory County harmless in the event of accidents or injuries occurring during the event, or during set up and closure of the event. A document must also be signed by the group or individual hosting the event citing that, in the event of damage to any property on the Courthouse campus grounds, the hosts are liable to pay for any and all costs.
