Gregory County Commission Proceedings

The regular meeting of the Gregory County Commission was held Wednesday, August 21, 2024, at 9:00 a.m. in Burke with the following members present: Jessy Biggins, Byrain Boes, Doug Janousek, Lance Matucha and Jeff Johnson. Also present: Julie Bartling, Gregory County Auditor and Patty Connealy, Gregory Times Advocate.

Chair Jessy Biggins called the meeting to order and all present recited the Pledge of Allegiance.

Approval of Agenda: Motion by Byrain Boes, second by Doug Janousek to approve the agenda with the following additions: Plat approval and travel requests. All members present voted aye. Motion carried.

Approval of Minutes: Motion by Lance Matucha, second by Byrain Boes to approve the minutes of the August 7, 2024 meeting as read. All members present voted aye. Motion carried.

Conflicts of Interest: The Chair asked if there were any conflicts of interest from members present. None were notated.

Ex-Parte Communications: The Chair inquired if there have been any ex-parte communications by any member present. None were notated.

Public Input: The Commission Chair opened the floor for public input.

The Board discussed an anonymous letter written to the Board regarding a fence that was placed in the right-of-way. The complaint was raised as to concerns of the narrowing of the road and safety issues with large equipment traveling the road.

The fence line was erected by Commissioner Byrain Boes and Michael Preslicka, who inquired of neighbors who had no concerns. The Board discussed that since the road is a county road and open to anyone to travel, the fence needs to be moved back further from the road's edge for safety concerns.

Commissioner Boes advised the Board that the fence will be moved.

Notice of Intent to Apply for USDA Funding: Motion by Jeff Johnson, second by Byrain Boes to continue forth with the application to USDA-Rural Development for funds to purchase a payloader and sheriff's vehicle, as a Notice of Intent to Apply has been given to the public. All members present voted aye. Motion carried.

Plat Approval: The following plat was presented to the Board for approval:

Approval of Claim: Motion by Lance Matucha, second by Doug Janousek to approve a claim from Chad Peck for repair of an overhead door at the Herrick Shop at the cost oof \$2,018.89. Mr. Peck did not get his bill turned in timely, thus the Board will make an exception to pay. All members present voted aye. Motion carried.

Wind Energy Systems Ordinance 2024-01-2nd Reading: Chair Jessy Biggins opened the hearing for the 2nd and final reading of Gregory County's Wind Energy Systems Ordinance 2024-01.

The Board read a letter from the Center for Rural Affairs citing concerns of the 3-miles setback as well as potential hindering of development.

Mr. Thomas Madsen called in asking questions regarding setbacks, noise, etc. Mr. Ed Dostal also raised concerns of electrical rates and violation of an individual's right to develop on his/her own property.

John Jacobsen, member of the Planning and Zoning Board, addressed comments regarding noise issues, setbacks and resources used while putting the ordinance language together.

Chair Biggins closed the hearing to public comment and opened it up for Board comments, questions and discussion.

Commissioner Boes commented on the lowering of land values once the turbines have used up their lifespan.

Commissioner Biggins expressed that he has no concerns with the 3-mile setback, as the developer could pay sufficiently for land to avoid the setbacks.

Motion by Doug Janousek, second by Byrain Boes to formally adopt Gregory County Wind Energy Systems Ordinance 2024-01. Upon call for vote: Doug Janousek-aye; Byrain Boes-aye; Lance Matuchaaye; Jeff Johnson-naye; Jessy Biggins-aye. Motion carried and ordinance is hereby adopted.

Bridge Inspection Report: Brad Stanghor, engineer from Ulteig Engineering, reported of the bridge inspections done across the county. For the most part, the bridges throughout the county are in good shape.

The following bridges will need attention:

FEMA funds may be available with stipulations to be followed. The Board is also discussing building the road without FEMA funds. Mr. Stanghor advised the Board to confirm that FEMA would pay and if so, what amount.

Highway & Bridge Report: Tyler Plumbtree, Highway Superintendent, reported on projects underway throughout the county.

Employee Hiring: Motion by Jeff Johnson, second by Doug Janousek to approve hiring Trey Bingen as a highway department employee effective August 26, 2024 at \$18.50 per hour. 2025 Budget Reductions: The following departmental budgets have been reduced, as agreed to by the office supervisors:

Highway Department - \$350,000 lower gravel hauling/construction Courthouse - \$70,000 lower construction/repairs Sheriff - \$65,000 lower for vehicle Director of Equalization - \$29,000 vehicle & software Courts - \$3,000 ROD - \$5,556 less salary, dues & fees

The Board will further discuss 2025 budgets at their next meeting, firmly setting all budgets.
