## **Gregory County Commission Proceedings**

The regular meeting of the Gregory County Commission was held Wednesday, October 2, 2024, at 9:00 a.m. in Burke with the following members present: Jessy Biggins, Byrain Boes, Doug Janousek, Lance Matucha and Jeff Johnson. Also present: Julie Bartling, Gregory County Auditor, Patty Connealy, Gregory Times Advocate and Peggy Glover, Commission District 2 candidate.

Chair Jessy Biggins called the meeting to order and all present recited the Pledge of Allegiance.

**Approval of Agenda**: Motion by Byrain Boes, second by Lance Matucha to approve the agenda with the addition of discussion surrounding a fence line in a R-O-W. All members present voted aye. Motion carried.

**Approval of Minutes:** Motion by Jeff Johnson, second by Doug Janousek to approve the minutes of the September 16, 2024 meeting as read. All members present voted aye. Motion carried.

**Conflicts of Interest:** The Chair asked if there were any conflicts of interest from members present. Commissioner Byrain Boes has a conflict with the fence line in the R-O-W matter.

**Ex-Parte Communications:** The Chair inquired if there have been any ex-parte communications by any member present. None were notated.

**Public Input:** The Chair opened the meeting for public input. Betty Jo Hoffman, Director of Equalization, met with the Board to get clarification on 911 addressing signs that are sitting in crates at the Highway Shop and whose responsibility it is to erect the signs. The Board advised Ms. Hoffman to take the matter up with the Highway Superintendent.
