The regular meeting of the Gregory County Commission was held Tuesday, February 4, 2025 at 9:00 a.m. in Burke with the following members present: Jessy Biggins, Byrain Boes, Doug, Janousek, Peg Glover and Jeff Johnson. Chair Jessy Biggins called the meeting to order and all present recited the Pledge of Allegiance.

Highway Safety Grant: Cody Spann, Chief Deputy Sheriff, discussed applying for a highway safety grant for "impaired driving". The grant would reimburse the County for vehicle expenses and overtime pay during the impaired driving surveillance. The deputy requests to further discuss the program at the next commission meeting.

Treasurer's Report: Kathy Serr, Treasurer reported that her copier no longer works so she will replace it soon.

Sale of tax receipts information, to outside vendors was once again discussed. The Board raised concerns about incorrect assessment values and that information regarding tax amounts payable should reflect correct amounts. Property owners have been in contact raising questions about their tax amounts. The Board will check into this further.

Motion by Peg Glover, second by Byrain Boes to set a price of \$7,500 for the complete property tax file when a request is made. All members present voted aye. Motion carried.
